## WHO IS ELIGIBLE FOR CALENDAR YEAR 2008 SOUTH BEACH HARBOR PARKING PERMITS

- 1) The slip licensee who is listed on the DMV registration or Coast Guard documentation.
- 2) Close family members - typically this will be limited to the spouse and/or children of the license holder.
- 3) Documented boat partners - If the boat is owned by a partnership, a copy of the partnership agreement must be on file.
  - Partnerships must have the prior approval of the Harbormaster. A valid Partnership Agreement requires that the original slip licensee maintains a significant ownership interest in the boat (normally at least 25% ownership) and remains personally active in the boat.
  - An eligible partnership will normally have such proof as DMV registration or Coast Guard documentation reflecting ownership by each of the partners.
  - A copy of the partnership agreement must be on file indicating the respective ownership interests, each partner's share of expenses and the share of profits and income upon sale, rental or other income generating use of the boat.
  - In all cases, the original licensee must remain as agent for the partnership, receiving all billings and signing all agreements.
  - Parking permits will be issued only to the original berth license holder.

### REMINDERS ON THE USE OF PARKING PERMITS

1. Permit parking is for authorized persons (see above) to park in designated areas *while they are at the Harbor using their boats*.
2. DO NOT SEND UNANNOUNCED GUESTS OR RELATIVES TO THE OFFICE TO REQUEST PARKING.
3. Subject to availability, tenants are normally allowed up to two temporary daily parking permits (per berth) for use of their guests while the tenants are at the Harbor using their boats. Normally, the tenants will come in to the Harbor office to get the permits, not the guests. On days expected to be particularly busy, tenants may be limited to one temporary permit until the lots are full.
4. Leaving vehicles for over 72 hours **while cruising** requires advance Harbor approval.
5. No other long-term storage of vehicles is allowed.
6. A cardkey is not a parking permit – it just gets you in the gate. A valid parking permit (either permanent or temporary) is always required.
7. **There will be \$10 service fee for 2008 permit applications that are returned after January 1, 2008 and a \$25 charge for replacing lost or misplaced permits. ANY LOST PERMITS FOUND IN SERVICE WILL SUBJECT THE VEHICLE TO TOWING AT THE OWNER'S EXPENSE.**
